This release extends and applies to, and also covers and includes, all unknown, unforeseen, unanticipated and unsuspected injuries, damages, loss and liability, and the consequences thereof, as well as those now disclosed and known exist. The provisions of any state, federal, local or territorial law or statute providing in substance that releases shall not extend to claims, demands, injuries or damages which are known or unsuspected to exist at the time, to the person executing such release, are hereby expressly waived.

EXHIBITOR RULES

1. Booth space numbers will be posted on wall/door of Civic Club Building on Friday before events.
2. List all items to be sold and sell only those items listed on application.
3. **NO ALCOHOLIC BEVERAGES ALLOWED** to be sold OR consumed.
4. Food booths are limited to 25 SPACES and the limitation on types of food will be upheld. A limit of 7 items per booth, excluding drinks.
5. Baked goods (cakes, pies, cookies, etc.) are **NOT TO BE SOLD** in the food Court. These are only to be sold in Arts and Craft area.
6. Travel trailers converted to vending facilities with air conditioners **MUST** have a portable, self-contained generator. This also applies to Any air conditioners used on Old South Day grounds. **NO AIR CONDITIONERS OR GENERATORS WILL BE ALLOWED TO PLUG INTO OUR ELECTRICAL OUTLETS.** They overload the circuits and trip breakers causing problems for other vendors.
7. **NO** food or beverages are to be sold in Arts and Crafts, **NO** arts and Crafts to be sold in Food Court. **NO** flea market items are to be sold in either area.
8. The following are **EXCLUSIVE** booths of Ochlocknee Community Civic Club, Inc.: sausage/biscuit, barbeque (chicken, pork or beef), cane syrup, and the Old South Day heritage quilt. **No Old South Day souvenirs will be sold by any other vendors.**
9. **Parking for vendors is behind Food Court.**
10. **No motorized vehicles allowed in exhibit area after 9:00am or before 4:00pm on day of events.**
11. Exhibitors must provide their own tables, showcases, heavy duty Extension cords and hoses for water connections.
12. Flea market items will include antiques, collectibles and **NEW** flea Market items only. **NO** junk, white elephant or yard sale items will **Will be allowed.**
13. **NO VULGARITIES OR HARMFUL ITEMS WILL BE ALLOWED TO BE SOLD IN ANY BOOTH. NO SNAP-N-POPS, STINK BOMBS OR POTATO GUNS, ETC. WILL BE ALLOWED.**
14. **FIREWORKS** are not to be sold by **ANYONE** on event days. Some Fireworks are illegal in the State of Georgia and Thomas County. We **The Ochlocknee Community Club, Inc.,** in compliance with Thomas County Fire Department , will enforce this. If **ANYONE** is found with Fireworks, they will be asked to leave.

15. EXHIBITORS MUST REMAIN WITH THEIR BOOTH(S) THE ENTIRE DAY.
16. Sizes of tents/canopies must be noted on application form. Anything Larger than 15'x15' will require two spaces. 20'x20' tents will require Four spaces back to back.
17. Booth chairperson reserves the right of acceptance and placement of All booths.
18. Exhibitors upon acceptance will be assigned a space giving priority to Those requesting same space(s) at check out time the previous year. Spaces will then be assigned as received.
19. NO UTILITY HOOKUPS ALLOWED FOR MOTOR HOMES, CAMPERS OR TRAILERS. NO MOTOR HOMES, CAMPERS OR TRAILERS ALLOWED IN EXHIBITING AREA AT ANY TIME DUE TO LIMIT OF SPACE. Parking spaces for these belonging to exhibitors will be allowed in vendor parking area behind food court. NO SHOWER FACILITIES ARE AVAILABLE. Portable toilets are located on tennis court (concreted area behind food court).
