This is your application/disclaimer for the Old South Day Parade on November 13, 2010, at 11:00 a.m. To participate in this year's parade, we must have this signed application. (This application may also be found at www.ochlocknee.info). Please follow all instructions issued by parade personnel.

GUIDELINES/RULES:

1. Participant's line up number should be placed in/on left front of your unit which is to be in the parade. Only those units with their line up number displayed will be permitted to enter the line-up area (East Railroad Street, north end). Line-up is in front of the Ochlocknee Baptist Church.
2. All other units and cars park either **BEHIND** the Ochlocknee Baptist Church or at the Ochlocknee United Methodist Church (which is across Route 3 from the Baptist church).
3. All parade entrants must be in place by 10:00 a.m. and NO LATER than 10:30 a.m. All parade entrants are responsible for providing his/her own unit/vehicle/etc. for the parade.
4. Please show identification for your unit -- people watching the parade would like to know who you are!
5. Persons with horses and other animals must stay off the parade line-up area (asphalt) until the parade begins. You may utilize the railroad right of way. **DO NOT RIDE HORSES OR ALLOW OTHER ANIMALS ON THE OCHLOCKNEE BAPTIST CHURCH PROPERTY OR THE OCHLOCKNEE UNITED METHODIST CHURCH PROPERTY, NOR IN THE YARDS OF THE HOUSES ALONG THE STREET. THANK YOU!**
6. If you are putting a float in the parade, you may bring the float Friday night (November 12, 2010), and place on the railroad right-of-way or no later than 9:00 a.m. on the day of the parade. There would be less congestion doing this.
